New Trash Can Ordinance

dents used to taking any trash can or bag to the curb and seeing the contents get hauled away. Those little green bins for recycling are also going by the wayside.

What does that mean for Hillsborough residents? Under Omaha's new trash contract effective January 1, 2021, most Oma-

ha residents will be issued two 96-gallon trash carts. One will hold trash and yard waste, to be picked up weekly. The other will be reserved for recycling, to be picked up every other week. The carts will arrive during the second half of 2020, up to 90days before the contract starts. If you prefer smaller carts, you may apply for a smaller cart after 90-days of receipt of the larger carts.

Why is this important today? Our Hillsborough Association covenants state that our trash cans must not be seen from the street (side or front of home). Be thinking about how you may need to change how you store your trash bins since the size will be changing. The 96-gallon carts are 29.75 inches wide, 35.5 inches deep and 43.5 inches tall. Each one should hold about eight typical 13-gallon bags of trash.
